#### **About the Decision Day events**

A Decision Day event will be held for each Brent Connects area. To take part in the event you will need to register in advance. These events will be participatory days where local residents will vote to decide which projects will be funded.

Only Brent residents aged 18 and over will be allowed to vote.

Applicants are required to present their project ideas to residents. You must confirm if you will present your project in person or will submit a short film. You will be allocated three minutes. If you prefer to submit a film then your film must not be longer than three minutes. All films must be submitted by 12 November to youdecide@brent.gov.uk
